Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When a SWMS has been revised, the person conducting a business or undertaking must ensure all:

- persons involved in the work are advised that a revision has been made and how they can access the revised SWMS;
- persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS; and,
- workers that will be involved in the work are provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

Encourage use of earplugs or earmuffs among employees.</li> <li>- Incorporate regular breaks during work to reduce continual exposure to high noise levels.</li> <li>- Promote adopting the correct lifting techniques when handling equipment/materials, reducing the risk of back pain or injury caused by improper methods. This includes using the strength of legs rather than back for lifting.</li> <li>- Implement a regular inspection regime for work areas and equipment to catch and reduce any potential hazards early.</li> <li>- Strictly enforce all safety guidelines and regulations among the staff to maintain a disciplined approach towards workplace health and safety.</li> <li>- Have a standby first aid kit and trained personnel ready for immediate action in case of any mishaps.</li> </ul> <p>It's essential to create a safe environment where everyone understands their roles, responsibilities and the crucial importance of maintaining safety at all times. 2. Wheel Loader Pre-use Inspection	Injury from moving parts, Uncontrolled release of energy	3H	<ul style="list-style-type: none"> <li>- Ensure that workers are fully trained and competent in inspecting and operating wheel loaders. They need to understand the nature of the hazards involved and the necessary safety requirements.</li> <li>- Operatives should be equipped with appropriate personal protective equipment (PPE) including gloves, hard hats, high visibility vests, and safety goggles where needed.</li> <li>- Complete a thorough visual inspection of the wheel loader prior to initiating operations - check for any visible signs of wear and tear or damage.</li> <li>- Check all moving parts of the wheel loader to ensure they are functioning correctly and safely. This includes lifts, hydraulics, brakes, and steering systems.</li> <li>- Inspect tyres for any signs of damage or excessive wear. Maintain adequate tyre pressure as per manufacturer's guidelines.</li> </ul>	2M

			<ul style="list-style-type: none"> <li>- Double-check all fluid levels – hydraulic fluid, engine oil, transmission fluid, coolant, and fuel. If any leaks are detected, action must be immediately taken to rectify the situation.</li> <li>- Use lockout/tag-out procedures when servicing equipment to prevent uncontrolled release of energy.</li> <li>- Confirm that all safety devices - horns, rear view mirrors, seat belts, warning lights, back-up alarms, and fire extinguishers are in good condition and working properly.</li> <li>- Document inspection checks using a pre-use checklist and report any faults immediately for prompt maintenance action.</li> <li>- Ensure seat belts are worn at all times while operating the loader.</li> <li>- Limit access to the area where the loader is operating to trained personnel only to prevent bystander injuries.</li> <li>- Establish a regular cleaning routine to ensure visibility isn't obstructed by dirt or debris.</li> <li>- Adequately light the operating area to avoid dangers related to poor visibility.</li> <li>- Always follow the manufacturer's operational procedures and safety guidelines.</li> </ul>		
3. Attachment Selection	Incorrect or faulty attachments, Misuse of attachment	3H	<ul style="list-style-type: none"> <li>- Provide training sessions to workers on the correct use of wheel loader attachments for various tasks.</li> <li>- Before using, inspect all attachments for any faults or damage to ensure they are fit for purpose.</li> <li>- Implement a maintenance schedule to regularly check and service the equipment. Faulty parts must be replaced immediately.</li> <li>- Maintain a log of all equipment checks and repairs for tracking purposes.</li> <li>- Ensure that the selection of equipment is appropriate for the task at hand. Using an inappropriate attachment could increase the risk of accidents.</li> <li>- Clearly label all the attachments according to their usage to avoid misuse.</li> <li>- Always make sure the machine operator has a clear view of the attachment during use.</li> <li>- Confirm that the rating of the attachment matches with the capacity of the loader before coupling.</li> <li>- Deploy a safety officer to double-check the attachments and provide advice if needed.</li> <li>- Educate workers about potential risks and how to recognise possible equipment failure signs.</li> <li>- Set up an emergency response plan, in case the control measures fail and accidents occur.</li> </ul>	1L

**SAFE WORK METHOD STATEMENT MONITORING AND REVIEW**

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are needed. The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
